Author Guidelines for Manuscript submission

Manuscript preparation: Manuscript should be prepared in MS Word. Manuscript should be typeset in double space on A4 size paper as Title, the name(s) and complete affiliation(s) of the author(s) clearly indicating the name of the corresponding author with his/her email id and If available, the 16-digit ORCID of the corresponding author. A running title of maximum 50 characters should be indicated. An abstract should include the scope of the work and principal findings of the paper and it should be between 200-250 words. Manuscript should be presented in the order of Abstract, Keywords (4-6 keywords), Introduction, Materials and Methods, Results and Discussion, Conclusion, Conflict of interest, Acknowledgements, References. Tables and Figures should have concise captions and be numbered using Arabic numerals. Tables and Figures should be mentioned in text.

References should be arranged alphabetically and set out as follows:
